## 2. Specification of the intended use and limitations

- Intended type of food in contact with materials: Candy, cookie crumbs, and nuts
- <u>Duration and temperature of food contact application:</u> 24 hours per day at up to 38°C (100°F)



## 3. Declaration

When used as specified, the following materials comply with the formulary and testing requirements of Commission Regulation (EU) No. 10/2011 as amended by Commission Regulation (EU) 2019/37 and the German BfR XV. Silicones, as applicable:

For the materials listed above, the overall migration does not exceed  $10 \text{ mg/dm}^2$  or 0.5% extractable components, as applicable, under the following test conditions:

- Repeated use
- Vegetable oil and poly (2,6-diphenyl-p-phenylene oxide), particle size 60-80 mesh, pore size 200 nm (Tenax)/40°C /10 days

The specific migration of substances that comprise the materials listed above do not exceed the legal limits of Commission Regulation (EU) No. 10/2011 and the German BfR XV. Silicones, as applicable, under the following test conditions:

- Repeated use
- Vegetable oil and poly (2,6-diphenyl-p-phenylene oxide), particle size 60-80 mesh, pore size 200 nm (Tenax)/40°C /24 hours
- 95% ethanol used in lieu of vegetable oil for one analyte because determined to be most severe compared to isooctane/40°C /24 hours
- Residual content testing, as applicable

Therefore, the finished product identified in this Declaration complies with the requirements of the Framework Regulation (EC) No. 1935/2004.

The finished product is compliant to Commission Regulation *(EC) 2023/2006 Good manufacturing practices for materials and articles intended to come into contact with food.*
