

Declaration of Compliance

The producer declares, that the following products:

Polyethylene cutting boards of high density polyethylene

(natural white, green, blue, red, yellow, brown, black / dimensions: 1/1 GN (W 530 x D 325) x H 18 mm.

Saro Order no: 387-3000, 387-3005, 387-3020, 387-3015, 387-3025, 387-3010 and 387-3030.

It is a compound of copolymer of ethylene – 1-hexeno with additives.

This material is in accordance with the 1935/2004 Regulation and the 10/2011 (UE) Regulation on materials and objects destined to enter in contact to food, developed specifically for plastic in the Directive 2002/72 and its later modifications. These directives have their transpose to the Spanish Legislation in the Royal Decree 866/2008.

Product analysis are performed on levels of migration, as determined by test methods 2 hours at 40 ° C and acid aqueous simulants 2-4-6 hours at 40 ° C in simulant oily, and with results expressed in mg/dm².

There is not applicable the Regulation (CE) 2822008 on materials and objects of recycled plastic destined to enter in contact with food, because in all that is not in use any type of material recycled for its elaboration.

It does not contain dangerous components in concentrations that should be born in mind, according to the directives of the CE.

The used raw materials do not present indexes of migration superior to the limits established in the previous regulations.


The substances authorized as additives for food are not present in the final product in such quantities that the migration to the foodstuffs could exceed the limits established in the current legislation in food matter or have a technological function in the final food.

In the transformation and production of tables compliance all the current sanitary procedure, while the company registered to the official spanish authorities in the corresponding R.D.G.S with number 39.04219 / A.

For all of this, our cutting boards and rolling pins can be used to enter in contact with all kind of food.

This guarantee refers to the indicated product, supplied in its original package and it will not be able to become extensive to:

- Any later modification of its composition, anyone that would be the nature of the substance that could be added.
- Any utilization that could turn it onto unnatural materials.
- Any inadequate use of the finished objects.
- Any checking of reciprocates compatibility among the material and the food in contact and particularly the non-modification of the organic properties of this kind of food.
